OBJECTIVES: A Term Note is primarily targeted at investors expecting a fixed amount at maturity of the product. It offers you the Final Redemption Amount being a cash amount equal to 100.00% of the Denomination plus the pro rata Coupon for the Tenor. There will be no coupon payments during the term of the product. The potential return is limited to the Coupon scheduled to be paid at maturity of the product. If the product is early redeemed, you may receive a redemption amount that is considerably lower than the Final Redemption Amount that would have otherwise been received. In such case, you may suffer a partial loss on its investment. Under normal market conditions, Bank Julius Baer & Co. Ltd. Zurich will endeavour to provide a secondary market (bid-only), but is under no legal obligation to do so.
