1. WHAT IS THIS PRODUCT?

TYPE: Swiss law governed notes.

TERM: The term of the product ends on the Final Redemption Date, unless the product has been terminated or redeemed early.

The risk indicator assumes you keep the product until 10 October 2024. The actual risk can vary significantly if you cash in at an early stage and you may get back less. Julius Baer has classified this product as 1 out of 7, which is the lowest risk class. This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact Julius Baer's capacity to pay you.
