1. WHAT IS THIS PRODUCT?

TYPE: Swiss law governed notes.

TERM: The term of the product ends on the Final Redemption Date, unless the product has been terminated or redeemed early.

OBJECTIVES: Outperformance Certificates allow you to benefit from an increase, with leverage, in the value of the underlying. The products will disproportionally reflect any positive change of the underyling, i.e. an investment in the product will outperform a comparable direct investment in the underlying. However, any negative performance of the underlying will be reflected directly, i.e. without leverage.

FINAL REDEMPTION: Unless previously redeemed, repurchased or cancelled, on the Final Redemption of the product on the Final Redemption Date, you will receive:

If the Final Level is at or above the Strike Price, a cash amount equal to the Denomination divided by the Initial Level, multiplied by (i) the sum of the Strike (a) Price and (ii) the product of the Participation and the difference between the Final Level and the Strike Price, calculated in accordance with the following formula:

2. WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

RISK INDICATOR



The risk indicator assumes you keep the product until 10 June 2025. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a quide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because Julius Baer is not able to pay you.

Julius Baer has classified this product as 6 out of 7, which is the second highest risk class. This rates the potential losses from future performance at a high level, and poor market conditions are very unlikely to impact Julius Baer's capacity to pay you.

Be aware of currency risk. If the currency of your account is different to that of this product, you will be exposed to currency risk, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.
