1. WHAT IS THIS PRODUCT?

TYPE: Swiss law governed notes.

TERM: The term of the product ends on the Final Redemption Date, unless the product has been terminated or redeemed early.

OBJECTIVES: Outperformance Certificates allow you to benefit from an increase, with leverage, in the value of the underlying. The products will disproportionally reflect any positive change of the underyling, i.e. an investment in the product will outperform a comparable direct investment in the underlying.
