# 1. WHAT IS THIS PRODUCT?

TYPE: Swiss law governed notes.

COMPETENT AUTHORITY OF THE

TERM: The term of the product ends on the Final Redemption Date, unless the product has been terminated or redeemed early.

OBJECTIVES: Call Warrants are leveraged products and allow you to benefit, with leverage, from an increase in the value of the underlying. Due to the leveraged nature of the products, a small amount invested can generate higher returns but also higher losses than will be reflected in the gains and losses respectively in the value of the underlying.

The number of products specified in the Ratio grant you the right to receive upon exercise an amount in cash in the Settlement Currency from the manufacturer provided that upon exercise the value of the underlying is **above** the Exercise Price/Strike. Therefore, if the value of the underlying is above the Exercise Price/Strike upon exercise, you will benefit, with leverage, from an increase in the value of the underlying in the form of a cash payment that increases depending upon the positive performance of the underlying. # 2. WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### **RISK INDICATOR**





The risk indicator assumes you keep the product until 19 December 2025. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because Julius Baer is not able to pay you.

Julius Baer has classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact Julius Baer's capacity to pay you.
