## 1. WHAT IS THIS PRODUCT?

**TYPE:** Swiss law governed notes.

**TERM:** The term of the product ends on the Final Redemption Date, unless the product has been terminated or redeemed early.

**OBJECTIVES:** Capital Protection Notes with a Lower and Upper Barrier are primarily targeted at investors expecting the value of the underlying to increase or decrease and that neither an Upper nor a Lower Barrier Event will occur throughout the term of such products. The product allows the holder thereof to benefit from a limited participation in a percentage of any positive or negative performance of the underlying (i.e. Payout Amount). Therefore, the potential return on an investment in such products is limited either to the Upper or Lower Barrier.

If the value of the underlying has developed unfavourably and will drop below the Lower Barrier, or will rise over the Upper Barrier, the holder of such product will receive the Final Redemption Amount (i.e. the Protected Redemption Amount). Investors in any such product should be aware that the Protected Redemption Amount may be less than the Issue Price (or, if different, the price the relevant investor paid for such product). The product provides for a continuous observation of the Barrier.

**FINAL REDEMPTION:** Unless previously redeemed, repurchased or cancelled, on the Final Redemption of the product on the Final Redemption Date, you will receive:

- If a Lower or Upper Barrier Event has occurred, the Protected Redemption Amount.
- If no Barrier Event has occurred, a cash amount equal to the Protected Redemption Amount plus the Payout Amount. The Payout Amount equals to the greater of the
  - Denomination x Downside Participation x ((Initial Level - Final Level) / Initial Level); or
  - Denomination x Upside Participation x ((Final Level - Initial Level) / Initial Level).

The product terms also provide that if certain extraordinary events occur, adjustments may be made to the product and Julius Baer may terminate the product early. These events are specified in the product terms and principally relate to the underlyings, the product and the product manufacturer. Therefore, investors should be prepared to sustain a partial or total loss of their investments.

## 2. WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### RISK INDICATOR



The risk indicator assumes you keep the product until 21 May 2027. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because Julius Baer is not able to pay you.

Julius Baer has classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact Julius Baer's capacity to pay you.

**Be aware of currency risk. If the currency of your account is different to that of this product, you will be exposed to currency risk, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.**

You are entitled to receive back at least USD 1,000.00 per product. Any amount over this, and any additional return, depends on future market performance and is uncertain.

#### COSTS OVER TIME

### 5. HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

**Recommended holding period: 21 May 2027 (maturity date)**

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity.

Disinvestment can only be done by selling the product either through the exchange (if the product is listed) or off-exchange, where an offer for such product exists. No fees or penalties will be charged by Julius Baer for any such transaction, however an execution fee might be chargeable by your broker if applicable. By selling the product before its maturity, you may receive back less than you would have received if you had kept the product until maturity.

In volatile or unusual market conditions, or in the event of technical disruptions, the sale of the product can be temporarily hindered or suspended and may not be possible at all.
