The product offers you a return in the form of conditional interest payments (i.e. Payout Amount(s) as specified below under Interest) and either a cash payment or the delivery of the Worst-Performing underlying on the Final Redemption Date, based on the conditions set out below. The risk associated with the investment in the product is comparable to the risk associated with a direct investment in the Worst-Performing underlying. The product provides for the observation of the Barrier only once on the Final Fixing Date.

FINAL REDEMPTION: Unless previously redeemed, repurchased or cancelled, on the Final Redemption of the product on the Final Redemption Date, you will receive:

- (a) If the Final Level of each underlying is **at or above** its Trigger Barrier, a cash amount equal to 100% of the Denomination; or
- (b) If the Final Level of the Worst-Performing underlying is **below** its Trigger Barrier, but above its Barrier, a cash amount equal to 100% of the Denomination; or

- (c) If the Final Level of **at least one** underlying is **at or below** its Barrier, the number of shares of the Worst-Performing underlyings specified in the Ratio. In addition, you will receive a cash amount in lieu for any fractional amount.

The product terms also provide that if certain extraordinary events occur, adjustments may be made to the product and the product manufacturer may terminate the product early. These events are specified in the product terms and principally relate to the underlyings, the product and the product manufacturer. Therefore, investors should be prepared to sustain a partial or total loss of their investments.

The product is intended to be offered to retail investors who fulfil all of the criteria below:

RISK INDICATOR



The risk indicator assumes you keep the product until maturity. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the manufacturer is not able to pay you out.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 26 June 2020 (maturity date)
