FINAL REDEMPTION: Unless previously redeemed, repurchased or cancelled, on the Final Redemption of the product on the Final Redemption Date, you will receive:

- (a) If no Barrier Event has occurred, a cash amount equal to 100% of the Denomination.
- (b) If a Barrier Event has occurred, and
 - (i) the Final Level of each underlying is at or above its Strike, a cash amount equal to 100% of the Denomination; or
 - (ii) the Final Level of at least one underlying is **below** its Strike, a cash amount equal to the Denomination multiplied by the ratio of the Final Level of the Worst-Performing underlying divided by its Strike Price.

The product terms also provide that if certain extraordinary events occur, adjustments may be made to the product and the product manufacturer may terminate the product early.
