OBJECTIVES: An Accrual Note is primarily targeted at investors expecting a fixed amount at maturity of the product. It offers you the Final Redemption Amount being a cash amount equal to 100.00% of the Denomination plus the accrued interest at the Bonus Rate during the Accrual Period. There will be no interest payments during the term of the product. The product provides you a termination right (Holder Put Option), subject to written notice. The potential return is limited to the accrued interest in the Accrual Period determined by reference to the Bonus Rate scheduled to be paid at maturity of the product. Under normal market conditions, Bank Julius Baer & Co. Ltd. Zurich will endeavour to provide a secondary market (bid-only), but is under no legal obligation to do so.

HOLDER PUT OPTION: On any Put Date you may exercise the right to require the manufacturer to redeem such product on the applicable Final Redemption Date at the Final Redemption Amount by delivering an Exercise Notice on or prior to 2 p.m. (CET) on such Put Date.

ISSUER CALL OPTION: On any Call Date the manufacturer may exercise its right to redeem the product, in whole but not in part, on the applicable Final Redemption Date at the Final Redemption Amount per Product by notifying you of such exercise on or prior to such Call Date; provided, however, that any outstanding product that is subject to a Holder Put Option exercised prior to such Call Date shall be excluded.

FINAL REDEMPTION: Unless previously redeemed, repurchased or cancelled, on the Final Redemption of the product on the Final Redemption Date, you will receive the Final Redemption Amount which is the Denomination and the accrued interest calculated as follows:

$$\text{Denomination} \times \left(1 + \text{Bonus Rate} \times \frac{\text{Accrual Period}}{360} \right)$$

The product terms also provide that if certain extraordinary events occur, adjustments may be made to the product and the product manufacturer may terminate the product early. These events are specified in the product terms and principally relate to the underlyings, the product and the product manufacturer. Therefore, investors should be prepared to sustain a partial or total loss of their investments.

The product is intended to be offered to retail investors who fulfil all of the criteria below:

The risk indicator assumes you keep the product until maturity. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 15 October 2020 (maturity date)
